All references to "Brifaland Hotel & Restaurant ", "we", "us" and "our" in this Privacy Policy are deemed to refer to Brifaland Hotel & Restaurant incorporated in Ghana ("Brifaland Hotel & Restaurant"). Brifaland Hotel & Restaurant has a strong commitment to providing excellent service to all of our customers and visitors of this website, including respecting privacy concerns.
